Description	Companies that provide expert advice to other entities on creating or optimizing a business process, technical and consultative studies, market sizing and customer profiling, technical services and consultancies with respect to applications, content and other relevant IT services and to enhance administration and technical performance.
Objective	To provide consulting services in the area of internet and multimedia to other entities.
Requirements	<ol style="list-style-type: none"> 1. Compliance with the Licensing Regulations 2003 and Licensing Categories Decision 2008. 2. Compliance with the Employment Regulations 2004.
Permissible Activities	<ol style="list-style-type: none"> 1. Engage/endorse with service providers / other consultants outside of the zone in order to provide consulting services to clients. 2. Creating or optimizing a business process / business model 3. Technical and consultative studies 4. Market sizing and customer profiling
Non-permissible activities	<ol style="list-style-type: none"> 1. Sponsored staff to work outside the Free Zone. 2. Import or export any products directly into the UAE market under its own name. 3. Enter into contracts for the sale of products into the UAE market. 4. Issuing invoices and receiving payments against invoices for sale of goods in the UAE market.
Special Conditions	<ol style="list-style-type: none"> 1. Consultancy licensees will not be allotted a customs code. 2. Sponsored staff working outside the TECOM Zone will be subject to clause No. 4.5 of the Employment Regulations 2004.
Violation of the Guidelines	<ol style="list-style-type: none"> 1. Any violation of these Guidelines will subject the Consultancy licensee to penalties as shall be imposed by the Authority. Persistent breach or repetitions may result in suspension and subsequently cancellation of a License.
